

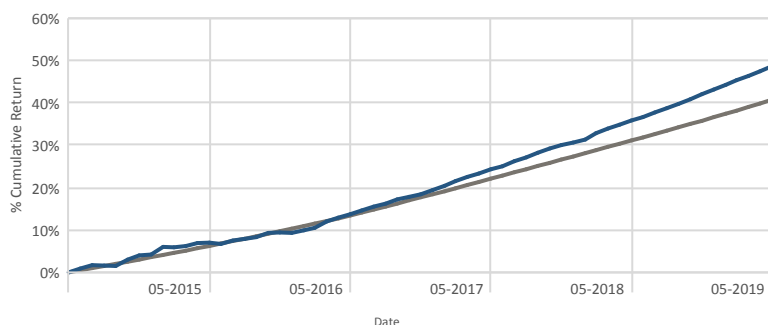
## INVESTMENT OBJECTIVE

The Sharenet BCI Income Plus Fund is a specialist income generating portfolio. The investment objective of the portfolio is to achieve a high level of sustainable income and stability of capital invested. Protection strategies may be implemented to reduce risk and volatility.

## INVESTMENT UNIVERSE

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. However, the portfolio's equity exposure may be as high as 10% of the portfolio's net asset value. The portfolio may from time to time invest in listed and unlisted financial instrument. The manager may only include the following unlisted financial instruments: forward currency, interest rate and exchange rate swap transactions.
